A Letter From the Chair & CEO

2023 was another exciting year at the Company. Building on our previous strengths, we remained financially strong while expanding in several key areas. The most exciting news to share is that the Company completed the acquisition of MedMal Direct Insurance Company (MDIC), a Jacksonville, Florida based medical professional insurance company, and its insurance agency, CorePRO. MDIC is currently licensed to write in 12 states with most of their business written in Florida, Georgia, and Texas. The acquisition doubles the Company's written premium to \$57 million and provides geographical diversity as we expand into several southern states.

The Company's risk management educational programs became nationally accredited in 2023 by the Accreditation Council for Continuing Medical Education (ACCME). The programs offer Continuing Medical Education (CME) on a wide range of topics, delivered through both live and online events. Our programs also include courses that satisfy state mandated licensing requirements. Practitioners can obtain a credit off their annual premium by completing Integris-sponsored programs.

The Company also completed a new facility product that provides liability coverage options for surgical, imaging, physical therapy, and urgent care centers. This is a growing segment of the market as care continues to transition to outpatient settings.

Our policyholder retention rate remains high, and we continue to maintain a strong balance sheet. The rise in interest rates over the past year has resulted in positive growth in our fixed income investment portfolio while the equity portfolio continues to demonstrate consistent long-term growth.

The Board of Directors approved a dividend to eligible policyholders equal to 2.5% of premium. In addition, we have continued the Legacy Rewards program, which annually allocates 5% of premium for each eligible policyholder to be paid at the time of retirement.

We dedicate this Annual Report to John Hornby, MD who retired as President and Chair of the Board in November 2023. Dr. Hornby was a policyholder for more than 35 years, a Board Member since 2006, and the President and Chair of the Board since 2017. Dr. Hornby was instrumental in guiding the Company through unprecedented changes in the healthcare industry and providing the expertise needed to keep the Company moving forward in the everchanging healthcare marketplace. We will miss his leadership, dedication, and wisdom and wish him well in retirement.

As always, we truly appreciate your trust and support. We are proud to say that the Company remains fully committed to its mission of providing you with exceptional protection and support. We look forward to continuing to serve your needs in the years ahead.

Assets, Liabilities, and Surplus \$ in Millions









Direct Written Premium









On December 31, 2023, Integris Group acquired Florida-based medical professional liability carrier, MedMal Direct Insurance Company, and its agency, CorePRO Insurance, LLC, from Physicians Trust, Inc. (PTI).


